Regular Monthly Meeting
June 10, 2024

The regular monthly meeting of The Board of Fire Commissioners, Township of South Brunswick, was called to order at 6:35 p.m by Chairman William Orchard, in compliance with the New Jersey Open Public Meetings Act.

Approval of May Regular Meeting Minutes: Mr. Hohmeier made a motion to approve the minutes as presented and Mr. Josephson seconded it. A vote was taken and passed unanimously.

Reports:

Line Activities – Chief Perez reported there were 25 calls; 1 drill and 2 work details. YTD there were 141 calls; 13 drills and 9 work details (file copy attached). In addition, on 6/8, there was a large structure fire in Kendall Park; there were no injuries and no damage to the trucks.

President – there was nothing to pressing to report.

Treasurer's Report/Voucher List – Ms. Berezansky presented the report (file copy attached). She reported that all bills had been paid, including the Commissioner payroll. After review of the Voucher List, Mr. Josephson made a motion to accept it and Mr. Hohmeier seconded it. A vote was taken and passed unanimously.

Secretary's Report- Mr. Olson was not present.

Fire Coordinator's Report – Mr. Perez reported the following:

- The crew from Engine 1 responded to 45 calls: 29 in Mon. Jct.; 10 in Kendall Park and 6 in Kingston. Everything has been working well.
- The Ladder Truck was inspected and needed some repairs.
- All trucks have been maintenance for the year.
- Rescue Truck repairs have been completed and it looks very good. In addition, all tools were serviced.
- A repricing was done for Truck 221 in the amount of \$70K. The paperwork will begin and should be ready for next month's meeting.
- The Chiefs' Vehicles titles have been received and they should be done by the end of August.

Chairman's Report – Chairman Orchard thanked Chief Perez, Mr. Hohmeier and Ms. Berezansky for their hard work making the day crews work out.
