April. 10, 2023

The regular monthly meeting of the Board of Fire Commissioners, Fire District No.1, in the Township of South Brunswick, was called to order at 6:30 p.m. by Chairman William Orchard, in compliance with the New Jersey Open Public Meetings Act.

Approval of Reorganization and Regular Meeting Minutes. Mr. Hohmeier made a motion to approve both sets of minutes and Ms. Berezansky seconded it. A vote was taken and passed unanimously

Line Activities – Chief Perez reported the following:

- Stats for March: 25 calls; 3 drills; and 2 work details.
- Stats YTD: 65 calls, 9 training drills and 6 work details.
- Daytime calls are the most, followed by afternoons, evenings and very few after midnight.
- Good training on the new rig board. It was intense but went very well.
- Did a membership drive at the high school; 11 expressed interest, but only 2 have followed up.

President's Report –The President was absent.

Treasurer's Report/Voucher List – Ms. Berezansky presented the report and stated that all bills had been paid. After review of the Voucher List, Mr. Hohmeier made a motion to accept it was presented and Mr. Orchard seconded it. A vote was taken and passed unanimously.

Fire Coordinator's Report – Mr. Perez reported the following:

- The Air Paks arrived and most have been put into service.
- The Engine is back in service but lettering will be done in about a month.
- The Ladder Truck is out for service because of a hydraulic leak, which will be repaired.
- The Rescue Truck had a breakdown during a drill. It will cost about \$700 to repair.
- The Bottles will be tested, now that the Air Paks have arrived.
